



Letter from the Vice President, Ray Fedele

Well it's nearing the end of our year and our last newsletter of 2013. I am writing this in place of the President since that officer position is still vacant on our board. We are also looking for someone to be our Technical Director that would help us with our CoveKeeper program and any water quality issues. If you are interested in those or any other position on the board please let us know.

2013 has been a year of change and accomplishment for the Lake Hartwell Association. The lake rose to over full pool, we had 100 year record rain fall, the Corps had to open the spillway to prevent a flood level (hasn't happened since the 70's), LHA appointed its first Executive Director and the Corps of Engineers appointed a new Commander of the Savannah River District.

Other significant events and activities the association promoted and participated in where;

- Two state caucus meetings between the legislators of both SC and GA. This is the first joining of forces that any states have ever participated. The second of these meeting included both

Governors and Lt. Governors of both states.

- Increased cooperation and discussion between directors and members of groups representing Lake Keowee, Lake Thurmond, Lake Russell and the Savannah River.
- A continued influence to law enforcement entities surrounding the lake that our property owners need protection from theft and vandalism.
- The signing of Phase Two of a comprehensive study on the Savannah River Basin between the Corps of Engineers, the State of SC, the State of GA and the Nature Conservatory to be conducted over the next year that will help determine water solutions in the Basin.
- LHA pressed the Corps for elimination, or at least a reduction, in the winter rule curve that drops Hartwell's level to 656 by Dec 1 each year. Due to that effort the Corps has announced that they will use a newly found \$240K to study this request.
- Clemson University's Intelligent River Project that will allow all stakeholders in the management of water along the entire basin to obtain real time data to optimize the use and quality of water.

WHEN TO REPLACE YOUR BOAT FIRE EXTINGUISHER

**Even if there's no expiration date,
it won't last forever.**

Manufacturers say most extinguishers should work for 5 to 15 years, but you might not know if you got yours three years ago or 13. So how can you be sure it will fire away? Atlanta fire chief Dennis L. Rubin recommends checking the pressure gauge monthly. "If the needle is in the green area, it's functional," he says. If it falls anywhere else, the extinguisher is

unreliable and should be serviced or replaced. For an older model without a gauge, have it checked by a pro. Rubin recommends annual servicing for all models. To find companies that refill and service extinguishers, check the Yellow Pages under "fire extinguishers."

Replace or service an extinguisher right away if it's been used or if you notice any of the following:

The hose or nozzle is cracked, ripped, or blocked with debris.

The locking pin on the handle is missing or unsealed.

The handle is wobbly or broken.

The inspection sticker or hang tag, with a record of checkups and maintenance, is missing.

As you, our members, are aware, a very basic tenet of the Lake Hartwell Association is to keep its members apprised of the latest information concerning Hartwell Lake. This includes news of relevant research, Corps activities, public opinion, lake activities, and actions of other entities which affect the health and maintenance of this very special resource.

With that in mind, this year the LHA Annual Meeting and Forum, October 5, agenda was designed to give you an important update on the Clemson Forest from Knight Cox, Manager of the Clemson Forest; the reality of the Intelligent River project from Drs. Gene Eidson and Jason Hallstrom of Clemson University and the Center for Watershed Excellence; and an introduction to the newly installed Commander of the Savannah River District, Corps of Engineers - Col. Thomas J. Tickner

Eidson and Hallstrom were given the lion's share of the agenda, and explained details of the Intelligent River concept, including the sensing fabric to collect data, the drop-in sensors, the mote stack, the web portal, and the IR Viewing Room presently under construction, among other things. In addition, Herb Burnham, past president of LHA, now Executive Director of LHA, gave a brief update on the activities of the Association.

We were also pleased to have Rep.

Alan Powell of the Georgia House of Representatives join us. Alan, together with SC Representative Don Bowen, are the two founders and major movers of the Savannah River Basin Caucus, a very important SC-GA group *For the Sake of the Lake*. Read more about this in Herb's article in this issue.

The meeting concluded with a buffet luncheon by Pam Garrett/Carolina Catering. After lunch, a guided tour in the Clemson Forest was provided, with Knight Cox and John Groton leading the way.

MORE PROGRESS ON PCB CLEAN-UP

Finding and mitigating PCB's in the area around Twelve Mile River on Lake Hartwell continues to be a long term effort. Schlumberger Technology now owns the land and the plant that left behind the PCB's, and has been a full partner in removing contaminated sediment from the river and now has begun excavating contaminated soil that has recently been discovered at the site.

This is an important effort. The presence of the PCB's puts people at risk, can harm wildlife and diminishes the recreation potential of this area. The chemicals attach to the sediment and are ingested by fish, and can be transferred to humans who eat those fish.

So far, the removal of the cancer-causing chemicals from the river has been a success, though further testing in the future will prove to what extent the PCB's have been mitigated. A test last year, however found that the level of PCB's was greatly reduced, and the risks from these chemicals are 25 times lower than EPA rules allow, according to the report at the time.

The mitigation effort included removing two dams from the river in 2011, along with some contaminated sediment that had collected behind them. The dams' removal is allowing fresh sediment to wash down the river and cap other PCB's that are trapped beneath.

Engineers say the effort has been helped tremendously by an exceedingly wet spring and summer including one storm in August that dropped nearly 6 inches of rain and totally cleaned out the riverbed returning it to its natural form, Nathaniel Cary wrote in a recent *Greenville News* report.

The work, by all partners, that has been done on the Twelve Mile to date as well as the rivers rebirth as a kayaking destination all testify to the importance of a continued effort to remove PCB's from Lake Hartwell once and for all.

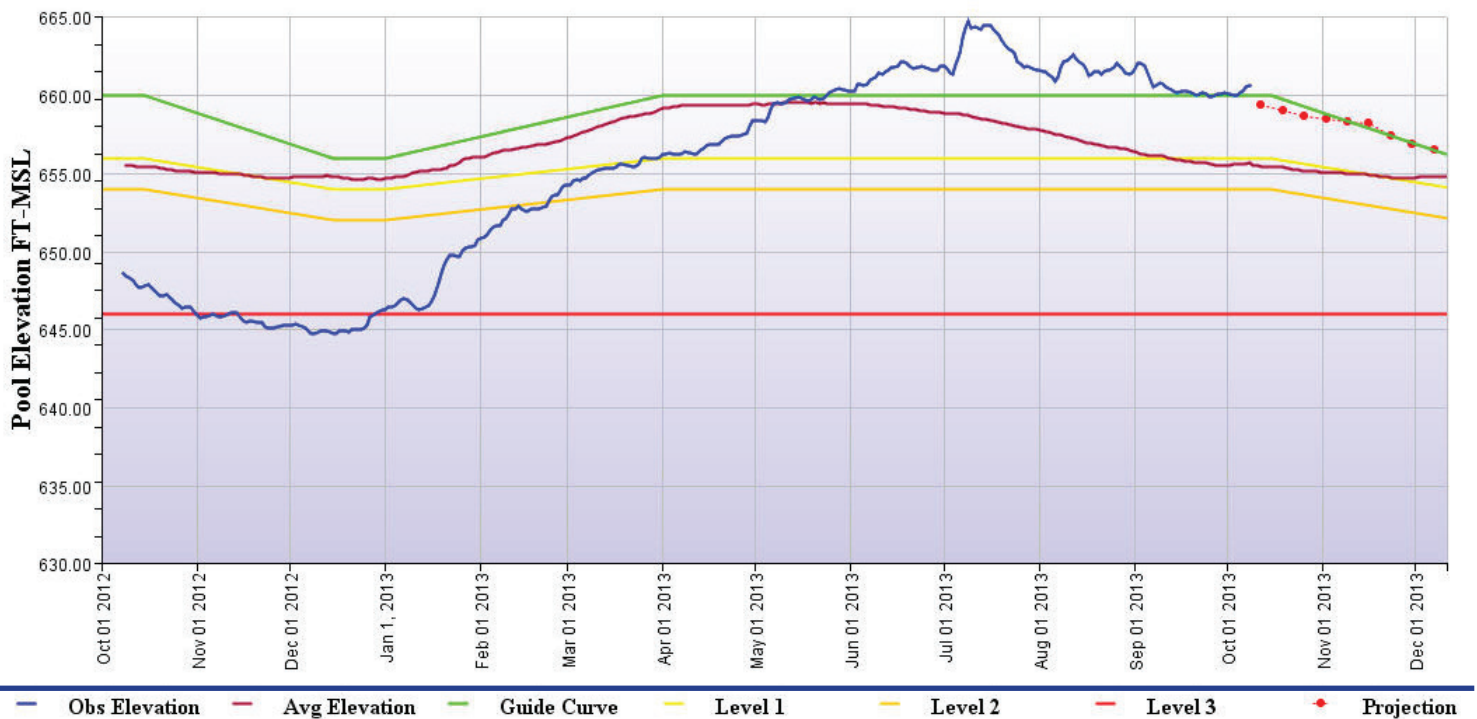

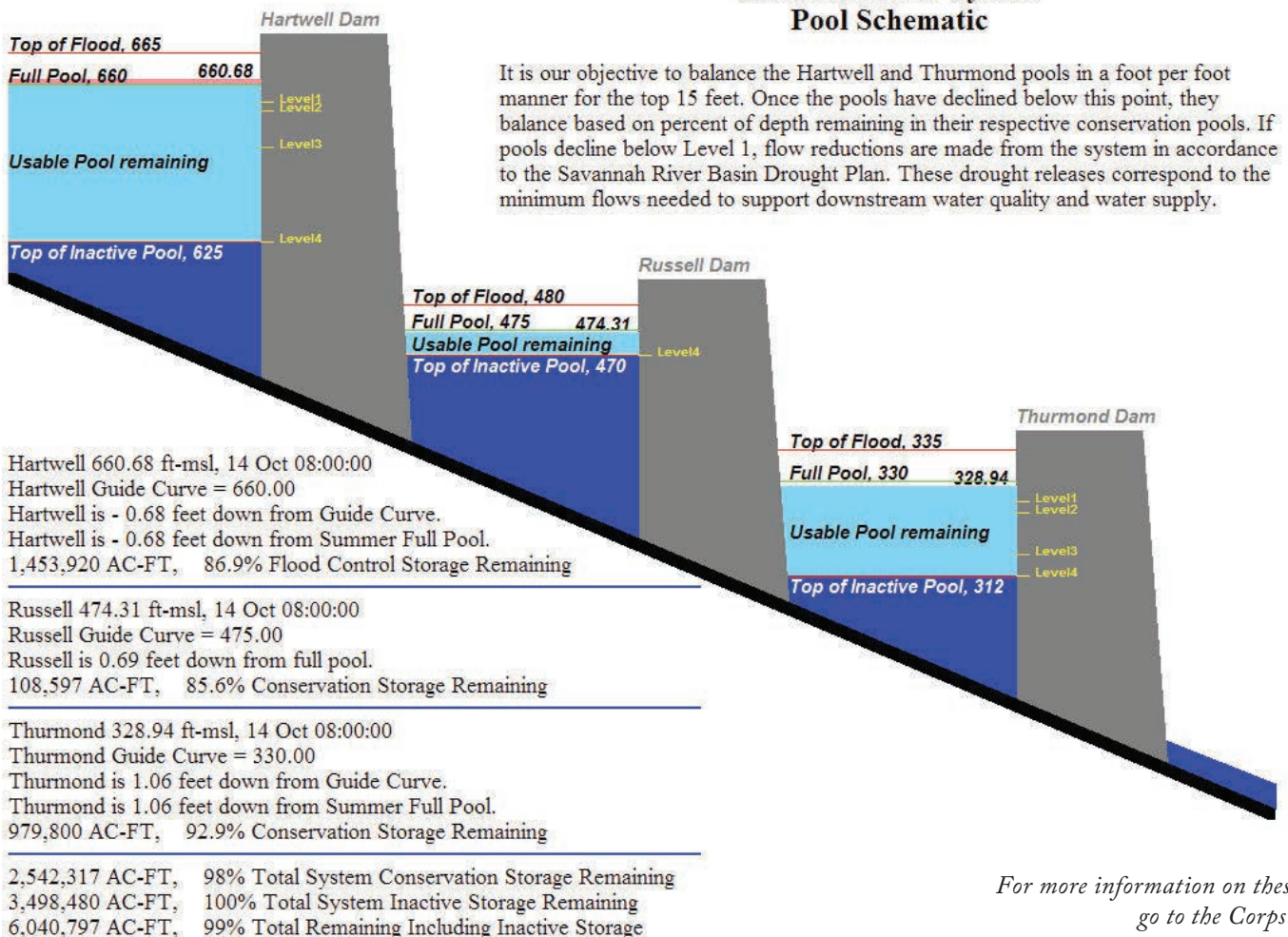


Lake Hartwell Elevations & Projections

Joint State Savannah River

The water in the Savannah River Basin, including Lake Hartwell, belongs equally to the states of South Carolina and Georgia. Because of the joint inter-state ownership, the Corps of Engineers, a neutral, non-partisan federal agency, is responsible for managing the basin. The cost of most anything done to improve management of the basin, such as flow management studies, is normally shared by the Corps and the two states. Therefore, all three will normally participate, and have equal authority in the studies, planning, and execution of any resulting changes. Impacts of the last two severe droughts in our basin clearly demonstrated the need to explore improvements in flow management at all times...not just when lakes reach predetermined drought levels. Thus, the need for the two states and the Corps to work together to once again study existing drought contingency plans that are based on historical climate and weather data.

A comprehensive study of the basin began more than a decade ago, and phase one was completed in 2006. Phase two, a detailed study of the existing drought contingency plan, was delayed due to the lack of funding from South Carolina. More recently, the Nature Conservancy organization offered to pay South Carolina's share so the study could proceed. The official study agreement was signed by the Corps, both states and the conservancy in a public ceremony during a joint state Water Caucus summit on September 18th, 2013. Both states, led by Representatives Don Bowen (R-SC) and Allen Powell (R-GA), have been working for several years to build a caucus made up of state assembly representatives and state senators,

for the purpose of ensuring that the states are keeping the management of their water resources high on the states' priority lists. Since both states share the Savannah Basin water resource it was appropriate that the two caucuses work in partnership toward its optimization. The first joint state caucus was hosted by South Carolina in Columbia on April 16, 2013. The September joint caucus was hosted by Georgia Representative Powell at the Big Oaks

Recreation Area near the Hartwell Dam. It was attended by both Governor Haley of SC and Governor Deal of GA, in addition to both Lt. Governors and numerous representatives, senators and key department heads from both states.

The Lake Hartwell Association worked closely with Representatives Bowen and Powell in organizing the September joint caucus to help ensure that stakeholders and advocates throughout the basin were represented. Several stakeholders, including LHA gave presentations regarding the need for optimizing the management of the basin through the use of adaptive management using real-time information. Dr. Eugene Eidson of Clemson University provided an update on the status of the Intelligent River Program he has headed for several years. This program, will provide the real-time data needed to make adaptive management of basin water possible. More information on the Intelligent River program is included in this issue.

Other speakers included stakeholders from upstream and downstream of Hartwell Lake. Harry Shelley representing Friends of the Savannah River Basin and Chairman of the

South Carolina Basin Advisory Council, reinforced the need for adaptive management to improve water levels in Lakes Russell and Thurmond as well as improved management of water usage in the Augusta area. Tonya Bonitatibus, the Savannah River Keeper assigned by the American Rivers Association to monitor and advocate for cleaner rivers, spoke of pollution concerns below Lake Thurmond. Several other speakers focused on the importance of the basin's water resources in terms of economic development and tourism, and overall regional commerce and economic sustainability.

Corps of Engineers Colonel Thomas Tickner, the new Commanding officer for the Savannah District, Alvin Taylor, director of the SC Department of Natural Resources and his GA counterpart, Commissioner Mark Williams also spoke to reinforce their concern and support of the need to optimize the management and use of the basin's water resources

All of the above set the stage for special guests and key speakers, South Carolina Governor Nikki Haley and Georgia Governor Nathan Deal. Both reinforced their understanding of the need to optimize management and protection of the basin, and pronounced their strong support of the joint caucus. They noted it was unprecedented for two states to work in partnership toward shared water solutions rather than "fighting it out in the courts".

The importance of the joint caucus meeting cannot be overstated. It truly shed new light on and strengthened both states' commitments to work in partnership towards improvements in water flow management, conservation and quality. The challenge now will be to sustain the momentum and the partnering spirit displayed at this bi-state meeting. It will take years of studying, planning and execution to get

there; and the goal should be to maximize the use of adaptive management techniques driven by real time data provided by sources such as the Intelligent River Program to optimize the use and quality of water throughout the Savannah River Basin.

It will be expensive, but certainly worth it. As we learned from the speakers, water in the basin is a primary ingredient in economic development and regional sustainability. Most will agree that the earth's climate has been changing since time began, and appears to be getting even more unpredictable; therefore, being prepared and able to quickly adapt to changes will become more and more critical. One of the conclusions of the authors of *The Future of Water*⁽¹⁾ states "The water resource managers who will look the silliest in the future are the ones who insist that the weather patterns of the past century are the best predictors of patterns over the next century. Flexibility and adaptability will be more important than ever."

The Savannah River Basin could well become the "showcase" for adaptive management applications using state-of-the-art real time data applications. The Lake Hartwell Association can be proud to be an advocate, leader and welcomed participant in its development. LHA members can help by encouraging others to join the association and giving it a more powerful voice. Tips for Proper Yard Debris Disposal

**Did you know that stormwater
is the *leading* threat to water quality?**

Yard debris can be transported to stormwater pipes and waterways, causing problems for you and your community.

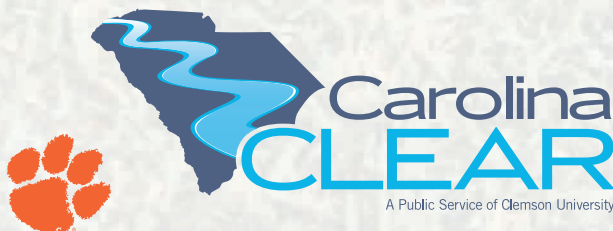
- Yard debris can clog stormwater pipes and ditches, causing flooding and costly maintenance, which may be passed on to homeowners.
- As yard debris decomposes, nutrients such as nitrogen and phosphorus are released into the water. This causes algae blooms, which are unsightly and can kill fish.

free Fertilizer, Anyone?

- Grass clippings and leaves return nutrients and water to the soil. Mulching mowers may be more efficient but several passes with any rotary mower will yield the same results with no impacts on turf.
- Use a blower or broom to keep grass clippings and leaves in the yard instead of blowing them into the street.

If you must dispose of yard waste, compost it or bag it for pick up.

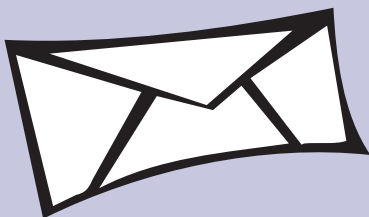
