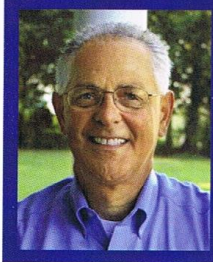

Letter from the President, Ray Fedele

Our year is winding down as an association as well as the seasons. 2014 has been a productive year with increased membership, renewals and excitement about the future of the lake. The association has been busy promoting your interests with the Corps as well as all the other stakeholders in the

Savannah River Basin. Here are some of our activities over the past year;

- Anderson County's new mega ramp was finished and ready for the B.A.S.S. Master Classic fishing event in the next few months. An executive of the event spoke to the members at the annual meeting in October and reviewed why they choose to return for a second time.
- We presented the Georgia Environmental Protection Department with a letter of objections on the pending water withdrawal permit at the under construction Plant Vogtle nuclear plant as well as opinions on the Corps new agreement with Duke Energy on re-licensing agreement for water releases from Lake Keowee.
- We solidified our cooperation with the lake associations above us on Lake Keowee and Jocassee, FOLKS and also the Friends of Lake Thurmond and Lake Russell below us.
- LHA and the Corps of Engineers sponsored the annual lake cleanup and provided an appreciation lunch for the participants.
- We reviewed all the past environmental assessment and master plans for the Sanctuary Point development in the Fairplay area. At this point there is no activity on this development since a current environmental impact assessment has not begun.
- Our Cove Keepers group is recruiting members and has conducted a number of training sessions.

WINTER TIPS FOR STORING YOUR BOAT

Even if winters are mild where you boat, you still need to be proactive about preventing problems.

Rain

To protect your boat during the rainy season, be sure that your bilge pump works and your battery has enough charge to run the pump. If you don't take your boat out, visit it after a heavy rain and at least once a month. You will save yourself a lot of heartache (and a bundle of money).

Winter storms

In winter, winds and storms often blow from a different direction. What effect will this have on your rigging? Consider all the places where your rigging might possibly strike, and take measures to prevent damage from any direction. You and your insurance company will be glad you did.

Dock lines and fenders

During fierce winter storms, frayed dock lines can part, damaging your vessel. Storms can also carry away your fenders. Be sure you have the correct dock lines for your boat. If you're not sure, check the guidelines in Chapman's and the West Marine catalogue.

Canvas covers

Check your canvas covers and canvas and vinyl superstructures (in your flybridge, for example). Stitching can come apart at the most inconvenient times, causing water damage in places you assumed were protected. This is another good reason to inspect your boat monthly and after every heavy storm.

Rodents

Many marinas have undeveloped land nearby that can be home to many small animals. These animals don't like cold weather any more than the rest of us do and seek warm shelter wherever they can. If you have a heat source or food aboard, your boat could be a target for rodents.

Safety

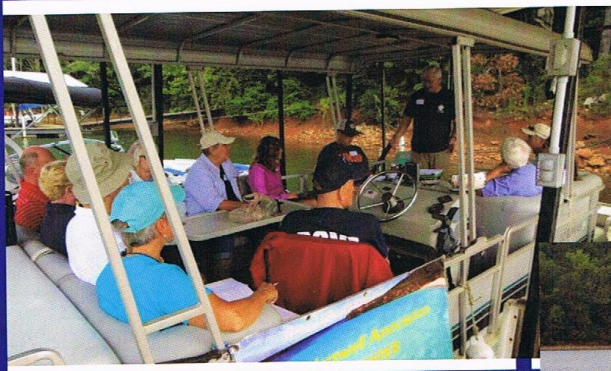
If you boat during the winter, wear adequate clothing and stay warm. Remember that the water temperature is colder and rain may make the currents heavier. Review the tide and current charts for your area.

New CoveKeepers Get Trained

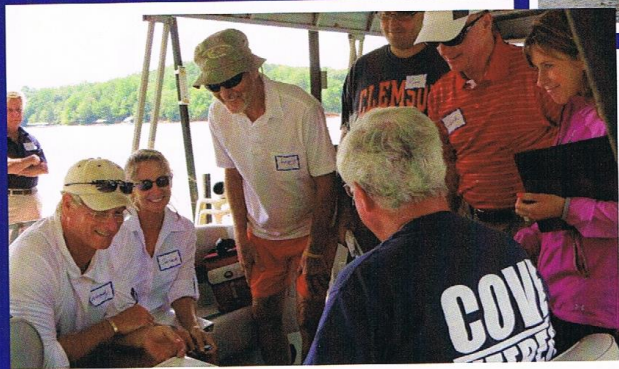
The CoveKeepers are growing by leaps and bounds thanks to Ruth Anne Maciag and Larry Dyck. When new CoveKeepers volunteer they must be trained so Larry, the originator of the CK group, trains them on what to look for and how to handle various situations that they encounter. During the training the volunteers learn not only what to look for but in addition they learn much about the Lake from a professional environmentalist, Larry. The instruction begins on land then quickly proceeds to on the water training, for hands on experiences. The Lake is divided into areas and each group tackles one area and reports their findings.

The \$4.1 million Green Pond site is ready. Crews finished pouring concrete for the 600-ton, multilane ramp in October, and grading and paving has been done with an official ribbon cutting ceremony scheduled for late December, according to Matt Schell, manager of the Anderson County Parks Department.

Visit Anderson executive director Jennifer Norman said preparations for the first event at Green Pond, the B.A.S.S Master Classic are coming along. She expects between 3,000 and 5,000 spectators on the eastern shore of Hartwell Lake at the new landing every day of the event.

"Prep is going well; we are really just working on logistics now," Norman said Wednesday. "We had a well-attended volunteer meeting and we are waiting on BASS to give us a few more details before we have another."

Built as a economic development driver, the new landing is living up to its mission. Because of it, the Hartwell Lake's 2015 tournament calendar is

getting crowded. In addition to the Classic, American Bass Anglers (ABA) announced that Green Pond Landing will host the 2015 American Fishing Tour National Championship Oct. 17 -23. More than 200 boats are expected to compete.

"We feel privileged to be working with a first class organization such as Visit Anderson," said ABA president Morris Sheehan. "With the help of Visit Anderson, this should be an AFT Championship for the record books."

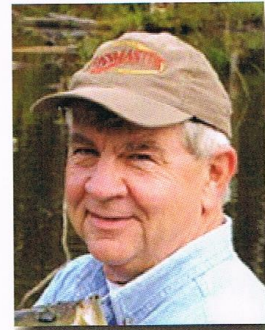
The American Fishing Tour was originally known as the Military Bass Anglers Association until its purchase by the ABA in 2000. Tour officials call it the "largest grassroots angler tournament trail" in the United States, with more than 80 divisions (19 in Georgia, Tennessee and South Carolina).

A Note from the B.A.S.S. Master Classic Tournament Vice President

Of all the fisheries to have hosted the GEICO Bassmaster Classic in its 45 years of existence, Lake Hartwell has to be among the most scenic. I was reminded of that fact during my recent visit to the lake at the invitation of Herb Burnham and the Lake Hartwell Association.



As we visited with Glenn Brill (director of the Anderson County Parks, Recreation & Tourism Division) at the Green Pond Landing site, I looked across the lake and thought back to February 2008, when the Classic was first held on Hartwell. Water levels were lower at that time than they are now, but the lake was no less attractive. And the fishing certainly didn't suffer. Winner Alton Jones of Texas caught almost 50 pounds of bass in three days on Hartwell under less than ideal conditions.

Although Jones did not qualify this year to fish the 2015 Classic, the field of 56 anglers in the tournament is filled with extremely skilled bass fishermen — the strongest contingent ever assembled, according to some observers.

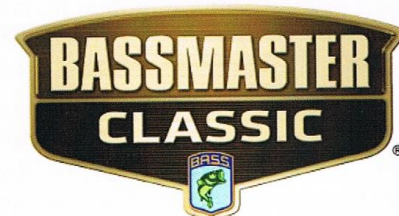
I also enjoyed my time with members of the Lake Hartwell Association during their annual meeting on October 18. I wish I had thought then to compliment the organization on their efforts to keep Lake Hartwell so beautiful. Instead, I spent my allotted speaking time giving a brief history of B.A.S.S. and the Bassmaster Classic and offering a glimpse of what fans can expect to see Feb. 20-22, when competition on Lake Hartwell gets underway.

The thousands of people attending the daily take-offs on at Green Pond Landing will see a first-class launch facility that is perfectly suited for the Classic. The hundreds who go out on the lake in their own boats will be able to cheer on their favorite professional anglers as they hunt for the winning bass — worth \$300,000 to the champion — somewhere in the lake.

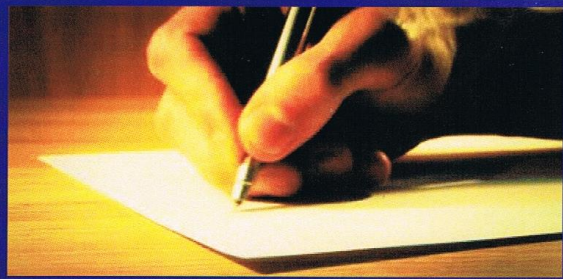
And those who check out the Classic Outdoor Expo presented by Dick's Sporting Goods in Greenville's TD Convention Center and the weigh-ins at the Bon Secours Wellness Center will find throngs of passionate fishing fans. And they'll understand why it's known as "the Super Bowl of Bass Fishing." Or why *Sports Illustrated Magazine* suggested in an article this year, "They really should call the Super Bowl 'the Bassmaster Classic of Football.'"

By the way, anyone wanting more information about the upcoming Bassmaster Classic can find what they need on www.bassmaster.com. And for those who can't get out on the water to watch the fishermen at work, the action will be broadcast live on that website, and several hours of original program will be aired on ESPN2 shortly after the event.

For a few days in February, Lake Hartwell will become the center of the universe for bass anglers worldwide.

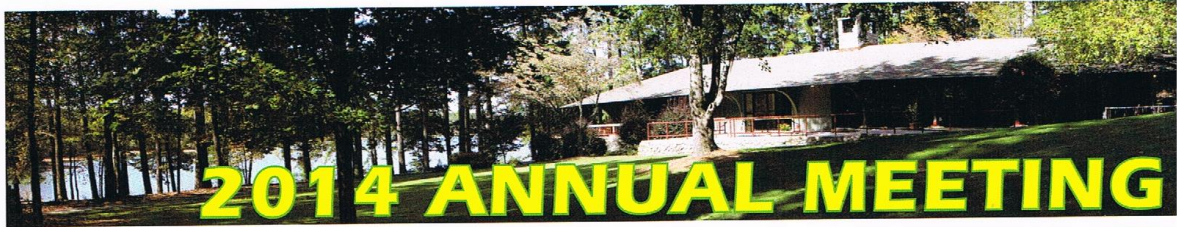

The Association's annual meeting was once again held in Kresge Hall located on the shores of Hartwell Lake in the Clemson Experimental Forest. That venue was selected not only because it is centrally located on the lake, but because it is one of the most beautiful natural settings in the area.

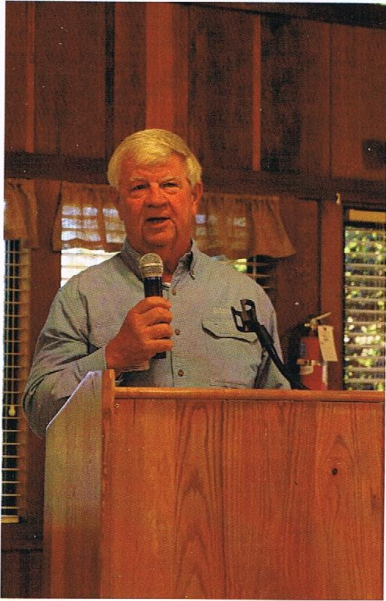
The meeting was well attended by members and special guests including a delegation from the Corps of Engineer's Hartwell Office and their District Office in Savannah. The delegation was led by its commanding officer, Colonel Thomas Tickner. Also attending were David Precht, a senior vice president with the B.A.S.S. Masters organization, State Representatives, Don Bowen (R) SC, and Alan Powell (R) GA. Also, as our welcoming speaker, Anna Simon, a well-known local author and retired Greenville News reporter.



Following a complimentary breakfast, Ms Simon gave an inspirational speech recalling her decades of experience working with the Association and reporting on its activities "for the sake of the lake". Included were notable events such as the PCB federal lawsuit and several droughts of record in which the Association and its members were involved.

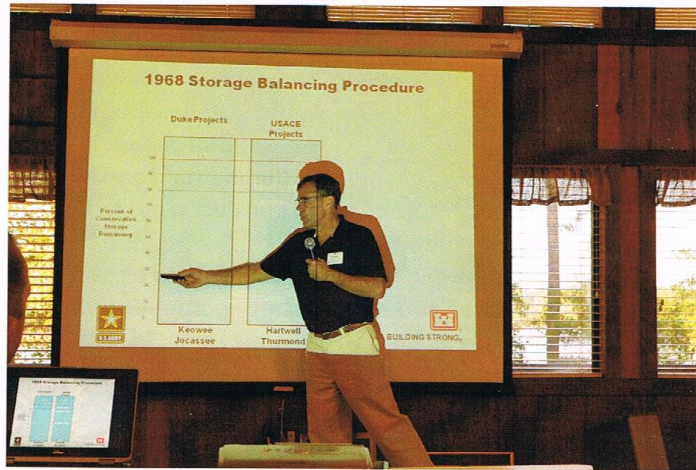
Those of us who were living in the area at the time will remember well the 2010 B.A.S.S. Masters Classic tournament that took place on Hartwell Lake. The Classic is considered the "Super Bowl of Bass Fishing", and we should take pride in being selected to once again host that event. Not only will it bring millions of dollars to the area, but will attract international attention to the lake and the region. David Precht, Senior VP of Communications and Publications for B.A.S.S. Masters was kind enough to drive up from Birmingham, AL, to address our meeting and answer questions concerning the Class. David was inducted into the Bass Fishing Hall of Fame years ago,





and this will be the 38th Classic he will have attended. At Dave's request, the Association arranged a pre-meeting tour of the new Green Pond facility, including project manager Matt Schell, who answered many of his questions and assured him the facility would be ready for the Classic in February.

The year 2013 will be remembered by many as the year the two states (SC and GA) formed Water Caucuses in their respective General Assemblies, and then came together to form a Joint Caucus focused on the Savannah River Basin. That joint caucus first met in September of that year, and was attended by the Governors of both states in addition to hundreds of stakeholders and state, federal



and local government officials. Its purpose was to create a working partnership aimed at improving management of the shared river basin, including the lakes. Following the joint meeting the Lake Hartwell Association, with assistance from its (stakeholder) counterparts on lakes Keowee and Thurmond, drafted a resolution for both states to consider adopting. The resolution specifically called for the Corps of Engineers to use more real time information and adaptive management (flexibility) in their control of water flows, especially during periods of drought. Both states' General Assemblies made minor changes to the draft and both adopted their respective versions. The original signed and sealed documents were presented to lake stakeholders during separate sessions of the General Assemblies in the respective state capitols. These framed documents were

presented to Colonel Tickner at the annual meeting. State Representatives Don Bowen and Alan Powell presented for their respective states. Both were leaders in getting their respective caucuses formed and in bringing the two caucuses together. Lake stakeholders participating included Harry Shelley of FOSRB for Thurmond and Russell, and Ben Turetzky of FOLKS for Keowee and Jocassee. Colonel Tickner promised the framed resolutions would be hung in a prominent location in his Savannah office.

As always, the meeting ended with the Corps of Engineers presenting an update on water management activities in the Savannah Basin and expectations for the near future based on current conditions and official

weather forecasts. Also covered was an overview of significant revisions in the drought contingency planning as a result of Duke Energy's recently approved agreement with the Corps based on Duke's new water management permit covering lakes Jocassee and Keowee. This includes some increases in releases into

Hartwell during droughts. Once again following the meeting, Silas Knight Cox, Manager of the Clemson Experimental Forest volunteered to conduct a guided nature tour which has become a pleasant and informative extra touch for meeting attendees. Thanks again Silas.

We welcome Margarit Gray, our new LHA Technical Committee co-chair! Margarit is a retired biology professor from Anderson University. The committee met in September to discuss the algae in Lake Hartwell, as well as other on-going projects: including the Green Pond boat ramp, Sanctuary Point development plans, the Phase II Comp Study status, and lake levels. Well it is group of interested individuals that review and monitor lake shoreline development, projects that affect the quality and quantity of water in the lake as well as establishing guidelines for the future of our most important resource water. 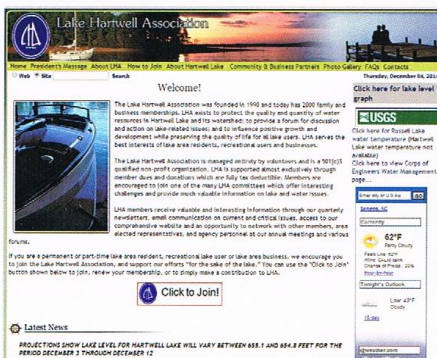

Anderson County Marine Patrol Encourages Dock ID

The Anderson County Sheriff's Lake Patrol (Marine One) is regularly patrolling the lake with a boat and two jet skis. The officers currently have to rely on GPS coordinates to determine a location of an incident or dock. This normally highlights an area with multiple docks as opposed to identifying a street address. They suggest placing your address on the side of your dock for easier ID.

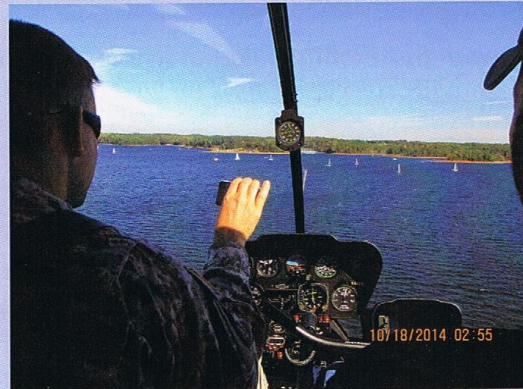


Lake front residents are reminded that Marine One's effectiveness is dependent upon our residents eyes and ears to notice anything suspicious or "out of place". Their e-mail is

One More Pool Rule



Although draining a swimming pool is sometimes necessary for maintenance or safety, where you drain that water can impact our environment and us. Pool water is treated with chlorine and other chemicals, which are toxic to fish and aquatic animals and plants. Improper pool discharge may also contribute to localized flooding issues around our homes and roads. When it's time for you to drain your pool, take the following precautions to help protect your community and downstream water quality.

Where should I drain my pool water?

- Contact your utility operator to find out if they will accept discharge to the sanitary sewer system. Do not drain your pool to a septic tank system.
- If the sanitary sewer is not an option, once you have taken the steps listed on the back of this card, slowly discharge your pool to a vegetated area of ground that allows water to soak into the earth. You must seek permission from your local municipal or county stormwater sewer authority prior to discharge to the stormwater system.

Remember, it is illegal for backwash or chlorinated pool water to be discharged to the storm drain system or a waterway!



If you need to drain your pool to the environment, take the following steps:

1. **Dechlorinate your pool.** Chlorine will dissipate from pool water if the chlorination system is turned off for several days or chlorine additions are stopped. If rapid dechlorination is necessary, chemical additives can be used. Before draining, water must be tested for residual chlorine. *Make sure that chlorine levels are below 0.1 mg/L.* Chlorine test kits can be purchased from pool supply stores.
2. **Check the pH.** Ideally, the pH should be between 6.5 and 7.5. A pH of less than 5 and greater than 8.5 can be harmful to aquatic life.
3. **If necessary, filter your water.** Is your water cloudy? High amounts of suspended solids can make pool water cloudy and is an indicator that there is algae, bacteria, sediment, or other debris present. Before draining your pool, use a filter to remove as much of the suspended solids as possible.
4. **Minimize erosion.** Don't discharge water onto bare or loose soil. Drain the pool as slowly as practical to a vegetated area of land.
5. **Ensure that pool water is free of algaecides.** Algaecides and other chemicals in pool water can harm plant and animal life in downstream waterways.

Local laws on pool discharges vary, so check your city and county ordinances. Contact a pool professional for assistance in making sure you properly drain your pool and protect our community and waterways.
