## **HARTWELL LAKE CAMPGROUNDS AND DAY-USE AREAS OPEN FOR 2019 SEASON**

The Corps of Engineers announced on April 1st the opening of six Campgrounds;

- Crescent Group Campground, Anderson County
- Springfield Campground, Anderson County
- Twin Lakes Campground, Pickens County
- Watsadler Campground, Hart County
- Singing Pines Day Use Area, Anderson County
- Twelve Mile Day Use Area, Pickens County

Campers to Springfield Campground will notice the results of a major tree cutting effort during the winter. Workers removed weaker Virginia Pine trees which are susceptible to disease and breakage during storms. They did so to reduce continual maintenance and public safety concerns resulting from falling trees. Natural Resources Program Manager Kenneth Bedenbaugh stated that "Campers returning in 2019 will notice significant aesthetic impacts to the overall appearance of the park. The area will be intensively managed to allow natural regeneration of beneficial tree species, supplemented by planting. This process will take time however and we ask for visitor's patience as we make long term improvements to the campground."

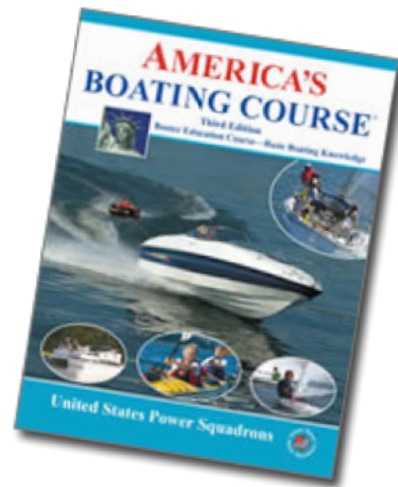
- Boat Handling Tips

## MEALS ON WHEELS POKER RUN

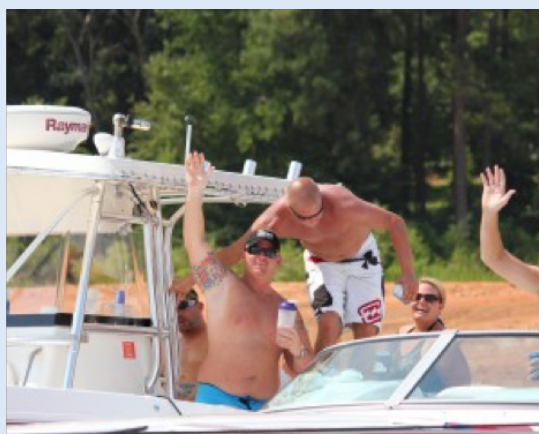

# LAKE HARTWELL BOATING SAFETY TIPS

1. **Be Weather-Wise.** Always check local weather conditions before departure - TV and radio forecasts can be a good source of information. If you notice darkening clouds, volatile and rough changing winds, or sudden drops in temperature, play it safe by getting off the water.
2. **Follow a Pre-Departure Checklist.** Proper boating safety means being prepared for any possibility on the water. From compliance with fire safety regulations to tips for fueling up, following a pre-departure checklist is the best way to make sure no boating safety rules or precautions have been forgotten.
3. **Use Common Sense.** One of the most important parts of boating safety is use your common sense. This means operating a safe speed at all times, especially in crowded areas. Be alert at all times, and steer clear of large vessels and watercraft that can be restricted in their ability to stop or turn. Also be respectful of buoys and other navigational aids, all of which have been placed there for one reason only - to ensure your own boating safety.
4. **Designate an Assistant Skipper.** Make sure more than only one person on board is familiar with all aspects of your boat's handling, operations, and other boating safety tips. If the captain is injured or incapacitated, it's important to make sure someone else can get everyone else back to shore.
5. **Make Proper Use of Life-jackets.** Did you know that the majority of drowning victims that are results of boating accidents, were found not wearing a Life-jacket? Make sure that your family and friends aren't part of this statistic by assigning and fitting each member of your onboard team with a life jacket-prior to departure.
6. **Avoid Alcohol.** Practice boating safety at all times by saving the alcohol for later. The probability of being involved in a boating accident doubles when alcohol is involved, and studies have also shown that the effect of alcohol is exacerbated by external effects such as sun and wind.

# KEEP LAKE HARTWELL BEAUTIFUL... FOREVER WITH A CONSERVATION EASEMENT

It is astounding that in 21 years, the Upstate's development footprint is projected to more than double in size. This means that a total area of land larger than Anderson County — formerly forests, farms, open space, and natural areas — will be converted to subdivisions, roads, shopping centers, and parking lots within the next two decades. This is far more land than we need to accommodate the region's population growth.

If this alarming trend continues, Lake Hartwell and the surrounding natural beauty will likely be irreversibly altered. For counties like Anderson, Oconee, and Pickens that rely on tourism revenue from boaters and vacationers alike, overdevelopment will cause significant negative impacts. The only way to preserve Lake Hartwell's character and the area's long-term economic health is to protect what makes it so special to tourists and residents alike: its scenic beauty, tree canopies, aquatic life, and water resources. One way to ensure that is to permanently protect your land with a conservation easement.

Many people have misconceptions about conservation easements. Does it mean I don't own my land anymore? Will all the rights I have to my property be taken away? The answer to both of these questions is no!

What a conservation easement does is permanently set aside areas that hold significant conservation values, such as property that borders Corps property along Lake Hartwell or streams that feed into the Lake. In short, it keeps vulnerable land from being lost to development. The landowner still holds rights to the property; the easement simply limits development potential according to their wishes. What the conservation easement does is formalize the landowner's long-term goals for their property while also meeting their present needs.

For example, farmers who put their farm in an easement still grow their crops and raise their livestock in the same way that they have been doing for years. A landowner who wants to harvest timber from their property can still do that, as long as there are best management practices implemented in their plan.

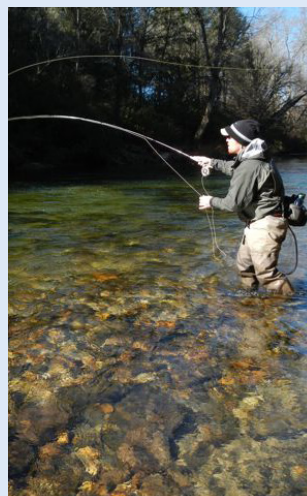
All conservation easements are entirely voluntary. In exchange for placing your land under a conservation easement, you may receive significant tax benefits. Sometimes funding is also available for conservation-minded landowners. Most importantly, you'll have the assurance of protecting your family's land forever.

But how does all this affect Lake Hartwell?

At Upstate Forever, a nonprofit accredited Land Trust based out of Greenville, SC, our mission is largely focused on preserving water quality. Although development can be positive for a community, it can profoundly damage the water supply. We are certainly not opposed to development, but we would like to see it done in a thoughtful, responsible way. By finding a balance between conservation and development, we can protect our resources, sustain the unique character of the Upstate, and ensure that Lake Hartwell remains a special, attractive place to live and visit.

# GREEN POND LANDING ATTRACTS PROFESSIONAL FISHING TOURNAMENTS

Several years ago, the Anderson County Parks and Recreation Department, under the leadership of director Glenn Brill, decided to improve and expand Green Pond Landing to take advantage of its close proximity to the city of Anderson and its visitor accommodations. At the same time professional fishing was growing more popular and becoming a big visitor attraction wherever they had weekend tournaments. Green Pond had all the basics needed to become what it has...one of the most popular professional fishing tournament locations in the USA. Obviously this makes Lake Hartwell one of the most popular fishing lakes and most visited lakes in the USA. Last year alone, for example, the Corps managed properties alone had more than 11 million visitors...not including Green Pond.

Having already expanded the Green Pond launching ramp to accommodate three boats at a time, Anderson County has plans to double the ramp's size. Parking for visitors, as well fishermen and their trailers, has been expanded. And the latest addition is a very attractive two-level modern restroom facility having two men's room and two women's restrooms, one of each on each level. As you can see from the accompanying photo, it's a two-story facility on a hill side. This is because the County plans to add an amphitheater next to it on the hillside which over-looks the lake. This will be available for public presentations as well as a viewing location for fish weigh-ins during tournaments.

Much of the funding for the above has been money the County received as part of the PCB settlement several years ago...money well spent!

Visit Anderson, headed by Director Neil Paul, is a very active organizations that promotes Anderson visitation. This organization held a well-attended press conference at the Green Pond Landing location to recognize two local professional fishermen on April 22nd. Both live in this area and had recently won champion trophies which they were very proud to display.

The accompanying photos of the press conference show Brandon Cobb of Greenwood and Brian Latimer of Belton holding their championship trophies they won on Lake Hartwell. Both consider it to be their "home lake" on which they learned to fish at a very young age, and spend a great deal of time practicing on Lake Hartwell between tournaments. LHA Executive Director, Herb Burnham, spoke with both about concerns with trash and other things they may see that are not good for the lake, and ask them to report same to him or the Corp of Engineers. Both agreed to do so.



## New aquatic species handbook available for SC Waters

This is a wonderful resource for learning more about the clams and mussels that live in Hartwell Lake and other lakes and rivers in South Carolina. Twenty nine species of mussels live in the waterways of South Carolina and we also have the Invasive Asian Clam, *Corbicula fluminea*. The main species of clams one sees in Hartwell lake are the small invasive *Corbulula*, which are usually about 1 to 1.5 inches wide or smaller. Our native Unionids, which are much larger (can be up to 9 inches long) have a hard time competing with the rapidly reproducing *Corbicula*.

Many of our freshwater mussels are now listed as endangered or threatened. They have declined for a number of reasons:

1. Mussels were once harvested for pearls and their shells were used for buttons.
2. Habitat degradation by sedimentation of streams and rivers, which occurs when there is not much vegetation growing around the edge of the body of water. This causes erosion when there is runoff from rain or other sources.
3. Pollutants and toxic substances that wash into the water from septic tanks lines, fertilizers, animal fecal material, road runoff and many other sources.

Mussels are filter feeders and can't tolerate their gills being clogged by sediment. They are also sensitive to many pollutants.

Freshwater mussels are important to our aquatic ecosystem, because they filter the water remove algae, bacteria and other organic material. They help improve water quality by removing these potentially harmful substances. They also help improve water clarity by removing sediment in the water column. Mussels also serve as a food source for a variety of animals.

Mussels are an indicator species of water quality. If the mussel population starts to decrease we know that something is wrong in our aquatic ecosystem.

*Corbicula fluminea* - These are abundant in Hartwell Lake. They were brought to North America in the 1920's by Asian immigrants, who used them for food. One can sometime see the shoreline littered with the shells of these clams. The shells of dead clams almost appear black, with the outer layer peeling, showing a white inner layer.

The native Unionid shells are much rarer to find around the shoreline of Hartwell Lake. The adults shells can be up to nine inches in length.

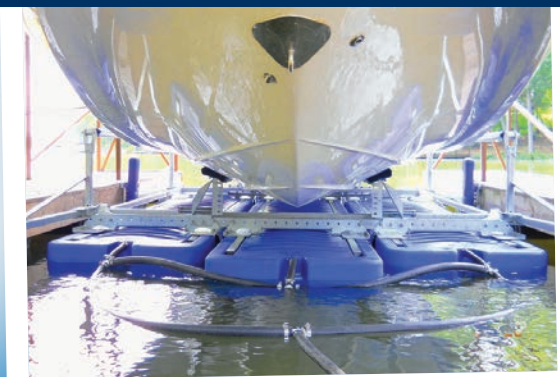
