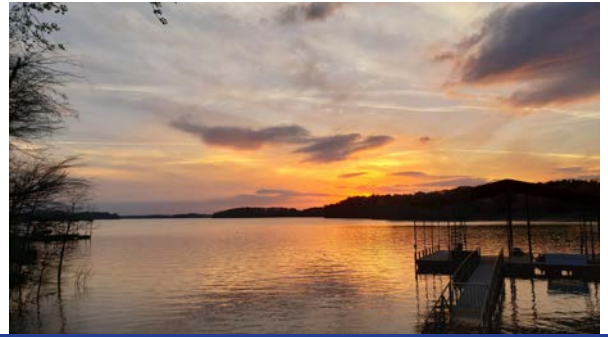

GREEN POND LANDING UPDATE

We'll complete our fifth phase of construction at Green Pond Landing & Event Center by June 2021. There are four components in this phase:

1. A 1,000-seat grassed amphitheater will be built on the west side of our peninsula. When not used by fishing tournaments, groups will be allowed to rent it for events.
2. A 240' courtesy dock will extend from the amphitheater into Lake Hartwell. A \$1 million grant from SC DNR is helping to pay for this portion of the project.
3. Power will be added to our Upper Truck/Trailer lot. This will allow anglers in tournaments having to leave their boats at Green Pond overnight to simply plug in to charge their batteries. Prior to this, the county would have to rent generators to power boats.
4. Two Host Sites will be added to the woods at the top of the peninsula. This will give us a 24/7 manned presence at Green Pond since our hosts will park their RVs in the park.

Last month, we hosted the 250-boat Bassmaster College Series Tournament at Green Pond on March 5-6. The tournament was originally planned to Lake Norman in NC, but Covid regulations in that state prevented the host county from issuing the necessary permit. BASS called Neil Paul of Visit Anderson just four weeks before the tournament asking if we could host it. I sat down with Neil and when we saw we could host it using money already in his budget, we told BASS “come on down!” This is the same tournament we hosted in August 2020.

That tournament generated \$878,000 in economic impact for Anderson County. This December 19th, when Green Pond turns seven years old its economic impact will be \$63 million. By its ninth birthday in 2023, that number will be more than \$87 million!



GET TO KNOW THE QUALITY OF WATER GOING TO LAKE HARTWELL

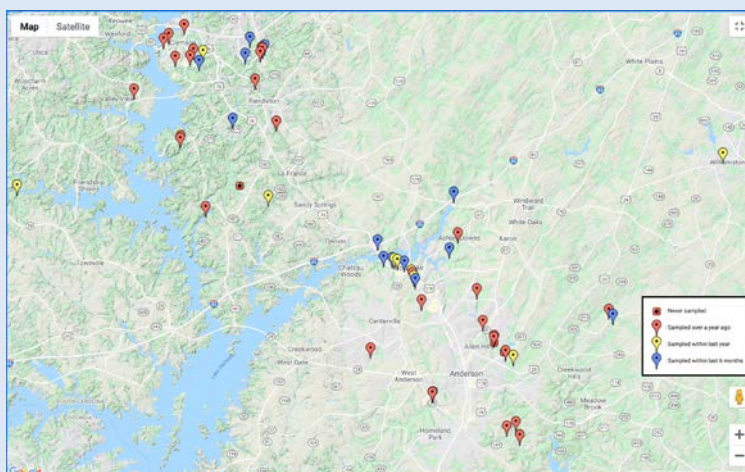

Lake Hartwell is iconic. It is a place of annual family gatherings, evokes memories of childhood fishing trips and that first striper on the line, our place to cool off come summertime, and so much more. In all of its vastness, hidden coves, and 900-miles of shoreline, Lake Hartwell is not an isolated waterbody. It is a large and living system, composed of river and stream networks in two states and three South Carolina counties. This full region draining to Lake Hartwell is called its “watershed,” a term many of you likely know as the area of land draining to a specific point on a waterway or reservoir. The quality of these contributing waterways is a major factor in the health of the lake and its suitability as a drinking water source, recreational waterbody, and home for wildlife and fish.

To gain a better understanding of the lake’s long-term health, we need to better understand the quality of the waterways draining to the lake, and you can help! A citizen science volunteer monitoring program is being offered across South Carolina that complements the state’s monitoring network and seeks to engage residents with their local streams, creeks, and rivers. The SC Adopt-a-Stream (SC AAS) program offers free trainings and access to monitoring kits to begin to collect data in smaller streams where water quality data is not likely to be collected. Equipped with a pollution reporting mechanism, the database is transparent and allows anyone to view the water quality data collected by certified volunteers. This data can and is being used at the local level to expedite solutions to water quality issues.

Even during COVID-19, when families were looking to get out of the house and participate in STEM activities, the program has grown, pivoting outreach to include virtual workshops and small group field trainings. Anderson and Pickens counties have some of the longest history with the program and years of data collection. So, here is my challenge to you! Join your neighbors in creating monitoring groups so that data is being collected on every major tributary flowing to Lake Hartwell! This is important and usable data to address Lake Hartwell’s continued health. There are several monitoring stations up for adoption, too, to the next group of dedicated volunteers!

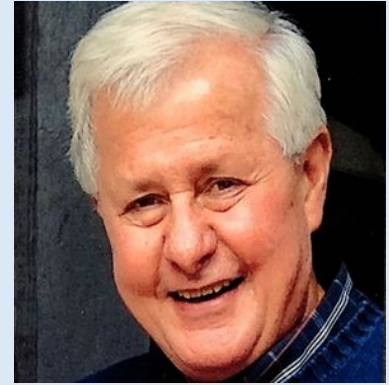
LAWRENCE "LARRY" DYCK OF CENTRAL, SC

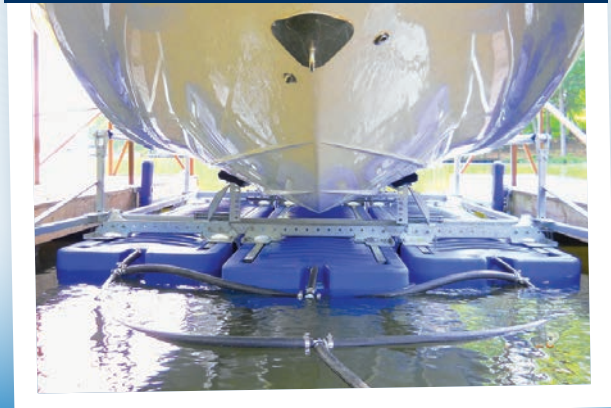

REDUCING POLLUTION IN THE THREE AND TWENTY CREEK WATERSHED

Upstate Forever is thrilled to be partnering with the Lake Hartwell Association and other local groups to reduce water pollution in the Three and Twenty Creek Watershed. The Three and Twenty Creek Watershed drains into Lake Hartwell, which serves as the primary drinking water source for over 200,000 residents in Anderson and Pickens Counties. Upstate Forever received funding in 2020 through the SC Department of Health Environmental (SC DHEC) to work with landowners in the watershed to reduce bacteria, nutrient and sediment pollution to local waterways. Failing septic systems, agricultural runoff, and development activities have all been identified as water quality issues in the Three and Twenty Creek Watershed. Through this program area residents can apply for financial assistance that will cover 60% of the cost to repair or replace failing septic systems on their property or to install agricultural practices on their property to reduce runoff and limit livestock access to waterways.

Funding is also available for landowners interested in permanently protecting their property through a conservation easement. Spring Cleaning Guide for Boats

Spring is a time when many of us clean up around our homes and yards. Preparing for the long anticipated warm weather should include our boats as well. The long months of inactivity are just as taxing on our watercrafts as on us. Sometimes it is fun to turn prepping the boat into an event for one of those wonderfully warm pre-spring days. Pitch a boat cleaning party and you can save a lot while setting the mood towards summer.

Many of us leave our boats in during the winter. I know I commit this sin with regularity. If you have a dock, you're supposed to use it, right? Well and good, but the bottom of my boat now looks like a Corps display of deadly invasive space slime mixed with creeping crud. I know I have lost 5 mph off my top end and gas mileage is shot. So, this is when I pull my boat and take it elsewhere to clean. Please DO NOT let this crud dry, ever! The work level gets insane, so try to pull your boat the day you will clean

the hull bottom. Once this part is done the time pressure is off. Interior mold can be removed with disinfecting spray cleaner, but expensive vinyl needs cleaning and protection from premium automotive or marine products designed for outdoor vinyl. Use the cleaner/protectant religiously all year and your interior will look new and stay that way. Once vinyl stains all bets are off. So never let that nasty stuff grow on your upholstery!

Check your battery. It is a good idea to invest in a battery maintainer, one that exercises the battery automatically. These digital chargers will periodically drain and recharge your battery if left plugged in. Suspect or older batteries should be pulled, charged, and tested. Go over the electrical system checking generators, appliances, lights, etc. Don't neglect your navigation and stern lights if so equipped, these are legally required whether you boat at night or not.

Check oil levels, if your engine has been sitting all winter it is often a good idea to go ahead and change it. Oil will go bad over time, even if the engine is not run.

On outboards check fuel tanks and lines for leaks. The sun and fuel both attack rubber and it wears out more quickly. For Inboard engines check the fuel lines and connections. If you have propane or other fuel sources check these and their fittings for filling and leaks.

If the engine does not wish to run suspect the old fuel first. Use fuel additive when you last fill your tank in the fall and you should not have a problem. Follow your owner's manual to check fuel filters, spark arrestors, etc. or have a local mechanic or marina look it over. Usually, a stubborn motor will crank with patience and a good battery. Remember to always store your boat with a FULL tank of gas plus stabilizer (additive). This makes it harder for water to condense into your gas tank and prevents gumming of injectors and carburetors.

It is best to run engines and generators at least every other week throughout the off season. This keeps fresh oil and fuel in the engine and will prevent any nasty spring surprises. Never forget that water is an engine's worst nightmare. We ask a lot of our marine engines and they require much more stringent care than land craft.

Check your marine radio. This is the perfect time to add that puppy if you've been putting it off. Handhelds are great, but the range is very limited. Full power mounted systems are far better with far greater range.

Check all of your lines (ropes) for fraying, rot and wear. Anchor rodes (that's a line tied to an anchor) should also be checked and restowed. Also fenders and any other devices used for mooring. One item I find indispensable is a boat hook. Even if you're the best boat driver ever, SOMEONE is going to ding your gel coat. It is also handy for fishing things back out of the drink and getting back off docks when someone boxes you in at the restaurant or gas dock. Finally please remember to "Never approach the dock any faster than you want to hit it".

And most important of all. Remove, inspect, repair or replace all life jackets and throwables. Please remember that life jackets must be readily available at all times. A jacket in it's wrapper or behind other gear in a difficult location is neither safe nor legal. There are some seriously cool life jackets out there now and there is no excuse not to wear one, But, if you choose not to it must be ready and accessible. I assign a vest to my guests and have them fit it and know where to grab it if needed. Most boating fatalities are drownings. One of your very first reactions to any emergency should be to insure everyone is in a life vest. THEN worry about the boat!

Corps of Engineers announces resumption of recreation fee collection at Hartwell.

U.S. Army Corps of Engineers has resumed day-use and boat launching fee collection at Hartwell beginning March 12 and will no longer accept cash at these areas. Automated fee machines that accept credit/debit cards only, have been installed at the seven locations where day-use or boat launching fees are charged (listed below). Fee collections were suspended since March 2020 due to COVID-19 concerns. The automated fee stations, made possible with CARES ACT funding, will also eliminate the need for continued cash collection and associated health concerns. The Corps charges a \$5 per vehicle day-use or boat launching fee at the following areas:

- Big Oaks Recreation Area, Hart County, Georgia (fee for boat launching only)
- Elrod Ferry Recreation Area, Hart County, Georgia (fee for day-use area only)
- Poplar Springs Recreation Area, Franklin County, Georgia (fee for boat launching only)
- Singing Pines Recreation Area, Anderson County, South Carolina
- Broyles Recreation Area, Anderson County, South Carolina
- Hatton's Ford Recreation Area, Anderson County, South Carolina (fee for boat launching only)
- Twin Lakes Recreation Area, Pickens County

South Carolina Corps of Engineers Annual Passes will be accepted and can be purchased for \$40. The pass allows unlimited nation-wide use of all Corps managed day-use and boat launching fee areas for a 12-month period from the month of purchase. Contact the Hartwell Project Office at 888-893-0678 to purchase an annual pass by phone or to obtain a list of campgrounds that currently sell annual passes in person. America the Beautiful – National Parks and Federal Recreational Lands Passes such as the America the Beautiful Senior or Access passes will also be accepted. Use of these passes do not require the purchase of a separate Corps of Engineers Annual Pass or payment of the park use fee.



LAKE HARTWELL SHORELINE MANAGEMENT PLAN 2020

The newly approved Shoreline Management Plan for the lake is now in effect. Arron Wahus, Hartwell Operations Manager stated “We felt the previous Plan served the project well but needed minor clarification of some requirements. Also, this updated plan incorporates information provided by residents, state agencies and others to set a more sustainable path for managing public land surrounding the lake”.

The most significant change is the new plan requires an inspection by a state licensed electrician of the electrical system on a dock every five years before renewal of the permit. This went into effect on February 1, 2021.

In Addition, dock owners may now use solar DC power to provide electrical service to a dock. Solar power does not require recertification every five years.” Not only is solar a clean safe energy source, but It also minimizes impacts to public land eliminating the need to trench-in traditional power lines. Solar power eliminates possible shock hazards for swimmers and eliminates moving electrical when “chasing the water” stated Sandy Campbell, natural resources manager at Lake Hartwell.

Additionally, utility rights of way and walkways are now considered supporting facilities for a dock so they can only be permitted if a dock is authorized.
